# OVID'S EVIDENCE-BASED MEDICINE REVIEWS (EBMR) DATABASES

Evidence-based medicine is becoming the favored method of treating patients by today's health care professionals, in particular the clinical setting, where time is premium. The use of the most current, best evidence available in medical literature for the care of a patient in any environment has lead to this review of some of Ovid's databases. The databases **Evidence-Based Medicine Reviews (EBMR)**, **Cochrane database** and **EMBR**, **Best Evidence** are available online or on CD-ROM.

**EBM Reviews, Cochrane Database** is prepared with content from the Cochrane Collaboration. (<a href="http://www.cochrane.org">http://www.cochrane.org</a>) It contains full-text topic reviews of evidence-based medicine literature and can be searched via abstract, keyword, author, text word, Implications for practice, publication type and document type to name a few of the

searchable fields that a clinician would find beneficial in searching the medical literature to care for a patient. All of the records at the time of writing had abstracts. This database is presented as the "bottom line" for doctors and nurses for EBM literature.

**EBM Reviews, Best Evidence** is prepared with content not just from the Cochrane Collaboration's database of Systemic Reviews , but includes "Best Evidence Medicine" a joint publication of the ACP and British Medical Journal Group and "ACP Journal Club" a supplement to "Annals of Internal Medicine", published by the American College of Physicians-American Society of Internal Medicine. Some fields that are searchable and of value to the clinician are: abstract, author, year of publication, keywords, journal name, publication type, reviewed source, commentary and author's institution. Again as writing all 1,600 records in the database have abstracts. This database markets itself as containing clinically-relevant articles from medical literature.

Coverage for both databases is 1991 to the present. Both of these databases can link with other Ovid databases thus allowing the user to follow a complete train of thought from a citation, to review, to the full text article. When deciding on which database to get, the environment of use must be considered. A quick review would lead one to believe that the EMB Reviews, Best Evidence would be the desirable database. In the teaching hospital environment where I work, this is what I have selected. This database allows for the treatment of the patient and provides the wide scope of literature that medical and nursing students are asked to provide when working on research projects and supporting patient care decisions and recommendations with additional literature. In a non-teaching clinical environment, I would be more inclined to get the **EBM Reviews**, **Cochrane Database** as it gives a review of the medical literature that has already had a "meta-analysis" performed and permits the clinician to get to the "bottom line" quickly and with confidence to treat the patient and answer their questions.

Mentoring activities, which result in publicity and acclaim for the profession and/or the Division

Other achievements indicating noteworthy dedication to the profession of special librarianship/information science.

4. The Contributions made by the candidate shall have been made over an extended period of time and shall be deemed to have had an enduring effect on the Division and/or the profession.

# WINIFRED SEWELL PRIZE FOR INNOVATION IN INFORMATION TECHNOLOGIES IN BIOMEDICAL AND LIFE SCIENCES LIBRARIANSHIP

The **WINIFRED SEWELL PRIZE FOR INNOVATION IN INFORMATION TECHNOLOGIES** is granted by the Biomedical and Life Sciences Division of the Special Libraries Association to a member who has shown leadership and innovation in the development and/or use of advanced technologies in the organization or dissemination of biomedical and life sciences information.

The Prize is named in honor of Winifred Sewell, who has been a member of the Biomedical and Life Sciences Division since 1946. Miss Sewell was Senior Librarian at Squibb Institute of Medical Research from 1946 until 1961. She was instrumental in the development of *MEDLARS* as Medical Subject Headings (MeSH) Specialist and later served as Deputy Chair of the Biological Services Division and Head of the Drug Literature Program at the National Library of Medicine. Miss Sewell served as President of the Special Libraries Association from 1960-1961, was President of the Drug Information Association from 1970-1971, and serves as Honorary President of the American Association of Colleges of Pharmacy in its 100th anniversary year in 1999-2000. She is the first woman and first librarian to be so honored. In addition, Miss Sewell is a Fellow of the Medical Library Association and is recipient of MLA's Eliot Prize for her book *Guide to Drug Information* (1977). In 1998 she was inducted into SLA's Hall of Fame at the annual conference in Indianapolis and currently serves on the Division's Awards Committee.

The Prize shall consist of an engraved plaque and a check in the amount of \$250.

The Division's Awards Committee shall select the conferee, based on the following criteria:

Innovation in developing and applying new technologies Commitment to educating others about new technologies Ongoing and sustained interest in fostering, creation or adaptation of emerging technologies to improve access to information in biomedical and life sciences.

The **Winifred Sewell Prize** will be awarded at the annual business meeting of the Biomedical and Life Sciences Division at the annual conference, but not necessarily every year.

# SLA Biomedical and Life Sciences Division Medical Section Business Meeting SLA Biomedical and Life Sciences Division June 10, 2000 Philadelphia, Pennsylvania

(Revised 7/11/00 Peggy Jones)

The meeting was called to order by Pam Barnard, the Medical Section Chair, at 11:10 AM. Barnard welcomed attendees, and an attendance sheet was circulated. Barnard introduced the incoming Section Chair, Peggy Jones, Pritzker Research Library, Children's Memorial Hospital in Chicago. Barnard thanked Majors Scientific for sponsoring this meeting.

June Carter delivered a presentation entitled "Evidence-Based Health Care": There is so much medical literature available today. Evidence-based health care (EBHC) is a way to keep up-to-date. Not all topics, however, have been researched sufficiently to apply EBHC. Critical or prevalent topics are more likely than routine medical topics to have the necessary research. The Cochrane Database takes the topical approach to EBHC, while journals such as Evidence Based Medicine take the article approach. How can librarians be involved in evidence-based health care? Some of the ways include: teaching the mechanics of EBHC to clinicians, using EBHC examples in MEDLINE classes, teaching EBHC to librarian colleagues, working with clinical faculty on EBHC projects, and putting together topical Cochrane reviews. EBHC hedges can be regularly used in MEDLINE searches to keep current.

A comments and questions period followed Carter's presentation. Barnard said that librarians can play a role by talking up the concept of EBHC to clinicians. Carter

mentioned that an EBHC slide presentation was given to first-year medical students at Northwestern University. Jo Anne Boorkman said that the University of California-Davis was going to start using EBHC in the Family Practice Department.

Lorri Zipperer, the Biomedical and Life Sciences Division liaison to the Medical Library Association (MLA), reported on the annual conference in Vancouver. Boorkman announced MLA's establishment of a new section, the Corporate Section. In response to a question regarding section foci, she explained that some MLA sections are functional and others focus on a particular library setting. The Corporate Section is entrepreneurial and functional, focusing on leadership and management. Naomi Broering announced that the Eight International Congress on Medical Librarianship will be in London in July 2000. This meeting occurs every four years.

Barnard reminded attendees that the reception and tour of the Mutter Museum, sponsored by the Medical Section, was to take place Sunday June 10th from 4 PM to 6 PM. She also reminded attendees that the Medical Section's program, entitled "The Transformation of Health Care in the Information Age," was scheduled for Tuesday, June 12<sup>th</sup> at 9 AM.

Barnard reported that the Procedures Manual for the Section is completed. Barnard brought copies of the manual to the business meeting for attendees to review. In addition, the manual will be put on the BIO website. Barnard asked for feedback on the Section's Strategic Initiatives. Boorkman suggested adding the BIO website to the initiatives: the Section needs to have more of a presence on the site. Barnard reported that the Section currently has 200+ members. It may be possible to obtain Section membership statistics from SLA Headquarters, but Bush cautioned that a new person at Headquarters is dealing with membership. She suggested that it could be possible to get Section membership statistics after a "settling in" period. One way to increase membership would be to invite SLA members whose primary division is not BIO to join the Section, as they might do so if approached. Barnard said that she would like to see more Section activity on the BIO listsery.

The next topic of discussion was whether to plan one or two programs for the 2001 annual SLA conference. Zipperer suggested a program on knowledge management in medicine. Her idea is a panel composed of different professionals - librarians, information technologists, etc. - that would appeal to a broad audience. Peggy Jones suggested a program on health care to the poor and under-served. Her idea is to draw on local speakers to discuss those populations still not being reached. Nancy Curtis thought that the program should include a technology update so that it doesn't just repeat the circuit rider focus. Anna McGowan, Zipperer and Boorkman added language and literacy issues, and consumer health, as potential topics. Also mentioned was the topic of the under-served professional community. Boorkman suggested another program to be considered: 24 by 7 reference service (electronic reference assistance). Annie Malley noted that this topic would tie in with the Contributed Papers Session topic for San Antonio: "Innovative Applications of Web and Digital Technologies in Biomedical and Life Sciences Libraries." Attendees agreed that the Medical Section should sponsor more than one program for 2001. Ideas for a reception/tour were discussed next. Jones will talk to local (San Antonio) SLA members to get ideas. Bush suggested the primate research

center, host of a 1991 BIO tour. Boorkman suggested Langley Air Force Base. Zipperer said that she will check with local MLA people for ideas.

Jones announced that the incoming Section Chair-Elect is Mary Glass from the ACOG Library. Jones mentioned that the secretary slot is open for next year, and that it will be a two-year position. Barnard thanked everyone for coming and adjourned the Medical Section Annual Business Meeting at 12:30 PM.

Two Recipients Selected to Receive Sternheim Scholarship Honors

Southern California Chapter, SLA

The Karen Sternheim Memorial Scholarship was established to provide assistance to a student enrolled in a graduate master's degree program in library and information studies who intends to pursue a career in special librarianship. Since 1996, the Sternheim Scholarship has been awarded annually by the Southern California Chapter of the Special Libraries Association. Now in its fifth year, there have been 38 applicants with six scholarships being awarded. For the first time, this year the Chapter was able to award two \$1500 scholarships.

**Laurie C. Blasingame** and **Natasha Bergson-Michelson** both masters degree candidates from San Jose State University are this year's Scholarship recipients.

Laurie expects to graduate from the SJSU, Fullerton program in May 2002. She is a member of the San Diego Chapter and a member of SLA's Biomedical & Life Sciences and Pharmaceutical Divisions. Already active in the Association she currently serves as the San Diego Chapter's Bulletin Co-Editor. A nursing undergraduate from San Diego State University '75 with 10 years working experience, Laurie's areas of interest are in medical/health science libraries and corporate libraries within pharmaceutical, biotech, and medical research or health information industries. Specifically Laurie's interests are in the design and implementation of systems that will integrate the biomedical knowledge base with emerging clinical information systems. Laurie is already working in her chosen specialization as a student intern at a health information company that will provide products and services to facilitate the exchange of clinical data and information. Laurie is a member of the Special Libraries Association, San Diego Chapter, the Medical Library Association and the Medical Library Group of Southern California & Arizona.

After receiving an undergraduate degree in Asian Studies, Natasha earned her masters degree from Harvard in East Asian Regional Studies. She is currently employed at The McKenna Group, a management-consulting firm where its Technology Information Center is clearly considered a company asset. Natasha expects to graduate from the San Jose campus during the 2000-2001 academic year. Her thesis project will provide a Web site that special librarians can visit anonymously to learn about their personal liabilities for copyright violations they must undertake as part of their work. Here librarians can learn how to protect themselves from such liabilities and, most importantly, a number of strategies they can use to convince upper management that copyright compliance is an

important and worthwhile expenditure. Natasha interests are focused on copyright, customer service and marketing special libraries. Natasha is a member of the San Francisco Bay Area and San Andreas Chapters, the Advertising & Marketing and Solo Librarians Divisions and a member of the Association's Public Relations Committee.

Both recipients admirably demonstrate what the Scholarship Committee believes is needed in future leaders: scholastic attainment; strong recommendations from academics and practitioners and focused, goal oriented plans. Above all their interest in and commitment to special librarianship was well developed in their written essay, their academic studies and in their professional references.

The 1999/2000 applicant pool was at its second highest with 11 applicants. A profile of this year's applicants reveals:

The Sternheim Memorial Scholarship honors Southern California Chapter member Karen Sternheim (nee Gersten) who was employed by the UCLA Management Library from 1980-1993. Karen was a very involved SLA member with a special affinity for students entering the profession. She was active in the UCLA Special Libraries Association student group; participated in the UCLA Library mentoring project; supervised information science graduate interns employed by UCLA's Management Library and was an active member of the SLA Scholarship Committee.

Karen recognized that students entering our profession are our collective future and as a mid-career individual, Karen chose to give back to the profession through developing student support systems. Karen believed passionately in her chosen career and was an advocate for it at every opportunity. It is fitting that the Southern California Chapter recognizes Karen's dedication and commitment with a student Scholarship in her honor.
