WINIFRED SEWELL PRIZE FOR INNOVATION IN INFORMATION TECHNOLOGIES IN BIOMEDICAL AND LIFE SCIENCES LIBRARIANSHIP

The WINIFRED SEWELL PRIZE FOR INNOVATION IN INFORMATION

TECHNOLOGIES is granted by the Biomedical and Life Sciences Division of the Special Libraries Association to a member who has shown leadership and innovation in the development and/or use of advanced technologies in the organization or dissemination of biomedical and life sciences information.

The Prize is named in honor of Winifred Sewell, who has been a member of the Biomedical and Life Sciences Division since 1946. Miss Sewell was Senior Librarian at Squibb Institute of Medical Research from 1946 until 1961. She was instrumental in the development of *MEDLARS* as Medical Subject Headings (MeSH) Specialist and later served as Deputy Chair of the Biological Services Division and Head of the Drug Literature Program at the National Library of Medicine. Miss Sewell served as President of the Special Libraries Association from 1960-1961, was President of the Drug Information Association from 1970-1971, and serves as Honorary President of the American Association of Colleges of Pharmacy in its 100th anniversary year in 1999-2000. She is the first woman and first librarian to be so honored. In addition, Miss Sewell is a Fellow of the Medical Library Association and is recipient of MLA's Eliot Prize for her book *Guide to Drug Information* (1977). In 1998 she was inducted into SLA's Hall of Fame at the annual conference in Indianapolis and currently serves on the Division's Awards Committee.

The Prize shall consist of an engraved plaque and a check in the amount of \$250.

The Division's Awards Committee shall select the conferee, based on the following criteria:

- Innovation in developing and applying new technologies
- Commitment to educating others about new technologies
- Ongoing and sustained interest in fostering, creation or adaptation of emerging technologies to improve access to information in biomedical and life sciences.

The **Winifred Sewell Prize** will be awarded at the annual business meeting of the Biomedical and Life Sciences Division at the annual conference, but not necessarily every year.

OVERDUE: More Than Dewey Needed to Access Information in this Age of Technology

Library school is a lot more than learning how to say "shhhh" and stamping books. It is a myth that all libraries use the Dewey Decimal System. There are male librarians. Female librarians are not required to wear cat-eye glasses; their hair pulled tightly in a bun, and long wool plaid skirts and sweater sets.

Ok, now that we got a chuckle and dispelled some myths, lets look instead at a serious topic facing student and professional alike - the need for technical skills in order to function as today's information specialist.

It does not matter if one is in a public, corporate or academic settling; there is no way to avoid the technological onslaught that has taken over the information world. Most people are comfortable with word processing and on-line catalogs, but we need to be equally as comfortable loading and maintaining CD ROM's, searching the web, using and evaluating electronic databases, and helping clients get more value out of the wealth of information that is available at their fingertips.

It was the fear of most information specialists that the Internet, and its easy accessibility to information, would make our profession obsolete. In reality, it has made us, and our skills, even more valuable and sought after in many nontraditional roles. However, it is vitally important that we as a group stay current with technology. To that end, we have to take courses that introduce us to innovations and classes that keep our skill sets current.

Taking continuing education classes is a requirement in many professions, such as teaching and nursing. We, as a profession, should adopt this concept as a priority. We are asked far fewer "ready reference" questions and instead are asked to focus our time and skill on fewer, more complex inquiries. Our clients are savvy enough to find the quick answers themselves and expect us to add value and clarity, to help them through the maze of information that is available in the world today.

Various organizations offer classes that are of interest to the information professional. Businesses like CompUSA offer introductory classes in various databases, HTML coding and basic computer skills. Regional Interlibrary Loan collaboratives, such as NELINET in the Northeast, offer courses in web design and cataloging. SLA offers a wide range of continuing education seminars, both real and virtual, at various meetings and times throughout the year. Colleges that offer accredited MLS degrees also offer courses that professionals can take, without applying for admission to a degree program.

Often, alum of these programs can even audit graduate classes at a reduced tuition rate.

While education is expensive, many employers offer tuition reimbursement for courses that are job related. In addition, many employers will pay for, or help to defray the cost of attendance at conferences, or even offer time off to attend these programs. Ask your manager to see what is available at your work place.

Taking classes while working is time consuming, and it can be hard to juggle work, school, and life. However, it is also very satisfying to learn skills that allow us to better serve our clients and enrich our services. As information professionals in the technological age, we can not afford not to take advantage of opportunities available to us. Our field is constantly evolving and those who do not also evolve will quickly become obsolete.
