BioOne was developed as a cooperative venture among the Scholarly Publishing and Academic Resources Coalition (SPARC), the American Institute of Biological Sciences (AIBS), the University of Kansas, the Big 12 Plus Libraries Consortium, and Allen Press.

INFORMATION TO CHANGE THE WORLD

Among their titles are *Ambio*, *BioScience*, *American Biology Teacher*, *American Zoologist*, *Biology of Reproduction*, *Copeia*, *Evolution*, *Paleobiology*, *The Wilson Bulletin*, and much more. Several titles with earlier holdings in JSTOR now have current issues available in BioOne. Please scan the whole list in the BioOne Archives at <http://www.bioone.org>.

Online issues try to retain all the information from the printed issues. Full-text articles are available in .html and .pdf formats. Features of the web site include browsing and an alerting service of tables of contents, a search engine that operates across multiple journals within BioOne, and linking to external electronic references (link resolver). On a recent test, the linking feature to external services worked well for services to which our institution subscribes (JSTOR, ScienceDirect, BioOne). Tips for Searching is worth a visit before you search, so you can take advantage of stem searching, wildcards, and more that are available at the site.

Table of Contents alerts and access to the citation abstracts are available to the public without a subscription. The annual subscription rate is determined by library type and size. For a modestly priced electronic service to support current interest in organismal and cellular biology, BioOne is an option worth investigation and potential support.

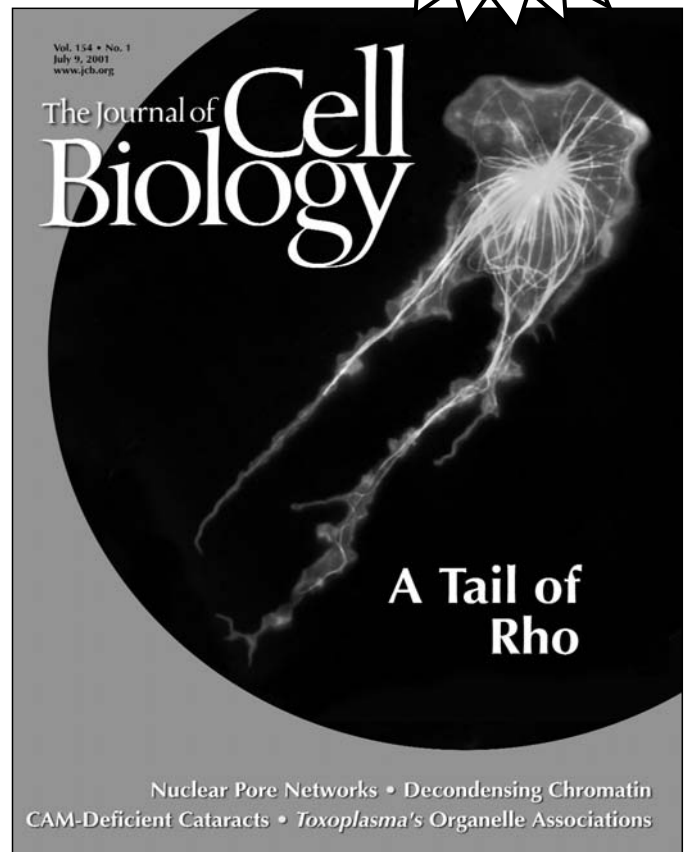
